- 1. Farai Kafeke with the FCGMA, representing the Watermaster, called the Initial Organizational Meeting of the West Las Posas Management Area Large Agricultural Group to order at 9:05 a m.
- 2. After reading a statement about the purpose of the meeting, Mr. Kafeke noted that the Watermaster would not be participating any further, and left the room.
- Mr. Rob Grether was selected to be the presiding officer (Mr. Nelson/Ms. Ferro/Unanimous).
- 4. Mr. Rob Grether indicated that per section 3.1.4 of the Watermaster Rules, he would take nominations from members attending the meeting to be candidates to be the group's PAC representative.
- 5. Ms. Ferro nominated Mr. Rob Grether to be the group's PAC representative. Mr. Rob Grether accepted the nomination.
- 6. Mr. Borchard nominated Ms. Ferro to be the group's PAC representative. Ms. Ferro accepted the nomination.
- 7. Mr. Poe asked about the nominees' interpretation of the duties of the representatives on the PAC and raised questions about the potential for PAC members to have conflicts of interest. Discussion ensued, but no action was taken.
- 8. Mr. John Grether called for the voting to proceed on the election of the group's PAC representative.

- 9. Mr. Rob Grether read out each WMID and Landowner name from the LPV Watermaster's List of PAC Constituency Group Designations (10/6/2023) provided by the Watermaster and waited for a meeting attendee to respond and indicate which candidate they supported. Attendees representing 10 of the 17 WMIDs in the constituency group responded.
- 10. Ms. Ferro received support from members representing 521.51 acre-feet of allocation basis. Mr. Rob Grether received support from members representing 4,959.71 acre-feet of allocation basis. Attached as Exhibit 1 is the record of votes.
- 11. Mr. Rob Grether received support from attendees representing 90.5% of the total allocation basis and was confirmed as the nominee for the West Las Posas Management Area Large Agriculture representative on the PAC.
- 12. Mr. Rob Grether resigned as presiding officer and chaired the remainder of the meeting as the PAC representative nominee.
- 13. Mr. Rob Grether asked if there were any other comments or questions from the group. Hearing none, he adjourned the meeting at 10:40 a.m.
