#### **MINUTES**

Minutes of the Fox Canyon Groundwater Management Agency's (FCGMA) **Videoconference** Executive Committee Meeting held **Thursday, May 14, 2020** in the Atlantic Conference Room of the Hall of Administration, Main Plaza, Ventura, CA 93009.

#### A. Call to Order

Chair West called the meeting to order at 2:00 p.m.

#### B. <u>Introductions</u>

In attendance were: (1) Eugene West, Chair; (2) David Borchard, Vice Chair; (3) Kim Loeb, FCGMA; (4) Keely Royas, FCGMA; (5) Jared Bouchard, Pleasant Valley County Water District (PVCWD); (6) John Mathews, Attorney; (7) John Lindquist, United Water Conservation District (UWCD); (8) Jurgen Gramckow, Southland Sod.

#### C. Public Comments

There were no public comments.

#### D. Approval of Minutes – February 12, 2020

Vice Chair Borchard made a motion to approve the February 12, 2020 minutes. Chair West seconded the motion, and the motion was approved.

### E. <u>Extraction Allocation During Transition to Water Year</u>

Kim Loeb introduced the item and stated that semi-annual reporting needs to transition from the current reporting period to the new water-year reporting starting October 1, 2020, as required by the Sustainable Groundwater Management Act (SGMA) and the new allocation ordinance for the Oxnard and Pleasant Valley (OPV) Basins. He explained that there needed to be a special two-month reporting period and allocation for agricultural (Ag) operators in August and September 2020, and that the annual allocations needed to be prorated for the nine-month period of January through September for municipal and industrial (M&I) and domestic operators.

Based on an analysis of monthly extractions based on Advanced Metering Infrastructure (AMI) data, staff recommended that August through September 2020 allocations for Ag operators be set at 35% of each operator's 2019/2020 Crop Year annual efficiency allocation. Based on analysis of monthly potable water production reported to the State Water Board by local urban water purveyors, staff recommended that the January through September 2020 allocations be set at 76% of Temporary Extraction Allocation (TEA) for each M&I operator and 76% of the baseline or historical allocation for domestic operators.

800 South Victoria Avenue, Ventura, CA 93009-1610 (805) 654-2014 FAX: (805) 654-3350 Website: www.fcgma.org Jared Bouchard stated that growers are in uncharted territory due to COVID-19 and he appreciates staff's recommendation to establish a simplified variance process for operators to provide evidence of different usage during the transition period

Vice Chair Borchard asked if the allocation for the 2020/2021 allocation would be reduced by the 35% used during the transition period. Mr. Loeb explained that it would not and the transition period would be treated as a separate reporting period.

Chair West stated that it seemed straightforward and Vice Chair Borchard agreed to make a move to recommend it the the full FCGMA Board.

### F. <u>OPV Variance Review Committee</u>

Mr. Loeb presented the item and stated that the Board adopted Resolution 2020-03 at the April 22, 2020 meeting, which reads "An applicant for a variance seeking additional allocation related to change in crops, change in land use, or receipt of water from a water purveyor shall have the request submitted to a variance review committee representative of the groundwater extractors in the basins." Mr. Loeb said that staff plans to send out a solicitation seeking interest for committee members, but that staff is seeking guidance on the size of the committee, the structure, and the process for selection of committee members.

Chair West recommended a Variance Review Committee with five to seven members, a structure in favor of groundwater extractors from the basins and for the Executive Committee to review and make a recommendation to the Board for appointment of the applicants.

Jared Bouchard asked for confirmation that it would be a combination of OPV. Mr. Loeb confirmed.

Mr. Mathews said that Pleasant Valley County Water District is in a unique situation and he hopes that each Board member doesn't get to choose one member.

John Lindquist asked if there were going to be any environmental representation on the committee.

Jurgen Gramckow stated that there needs to be knowledgeable users who are on the ground every day. He also said that the maximum number of members should be seven.

Vice Chair Borchard stated that he agreed with Mr. Gramckow.

Chair West stated that he thinks five is better than seven if there is equal representation. He said that with regards to structure staff should do a simple analysis of use of the basins. He also said that the solicitation for members should be done sooner rather than later and be brought back to the Executive Committee for recommendation.

#### G. Future Agenda Items and Next Meeting Date

Items to be discussed at the next Executive Committee meeting are the received applications for the OPV Variance Review Committee. The next meeting date is set for June 10, 2020 at 10:30 a.m.

Resolution 2020-03 Establishing Policies and Procedures for Granting Variances from the Initial Extraction Allocation Under the Ordinance to Establish an Allocation System for the Oxnard and Pleasant Valley Groundwater (OPV) Basins was adopted by the Board at the April 22, 2020 meeting.

The Resolution was based on recommendations of the Executive Committee and identified "other variance requests" and which would be reviewed by a Variance Review Committee:

An applicant for a variance seeking additional allocation related to change in crops, change in land use, or receipt of water from a water purveyor shall have the request submitted to a variance review committee representative of the groundwater extractors in the basins. The recommendation of the committee shall be provided to the Board for its consideration of the variance request.

At the May 14, 2020 meeting, the Executive Committee recommended that the Variance Review Committee consist of 5 to 7 members representative of the groundwater extractors in the OPV Basins.

The Agency solicited applications for serving on the Variance Review Committee with a submittal deadline of June 5, 2020. Seven applications were received. The table provides a summary of the applications; copes of the applications are attached (phone numbers and email addresses have been redacted).
