MINUTES

Minutes of the Fox Canyon Groundwater Management Agency's (FCGMA) Executive Committee meeting held **Friday**, **July 15**, **2016** in the Mediterranean Conference Room, 3rd Floor of the Ventura County Government Center, Hall of Administration, 800 South Victoria Avenue, Ventura, California.

- A. <u>Call to Order</u> The meeting commenced at 1:03 p.m.
- B. - **C.** Public Comments No public comments were made.
- **D.** <u>Meeting Minutes</u> The Executive Committee approved the minutes from the January 21, 2014 meeting.
- E. Brackish Groundwater Pumping Policy

Mr. Tully Clifford, FCGMA Assistant Executive Officer, presented the drafted Brackish Groundwater Pumping Policy ("the Policy"). Stakeholders have been very responsive. A meeting was held on June 29, 2016 and additional comments have continued to be received since then. The policy has been updated numerous times, and is an ongoing process. A flowchart has been added as a quick reference guide regarding how or when a project would be considered under the policy. The most recent changes to the Policy include refinements regarding the Groundwater Sustainability Act (GSA) and to keep the terminology with SGMA fluid and to meet SGMA requirements. One of the main Stakeholder concerns was that there didn't seem to be any mention of how the water is to be used or how it will be distributed (it has since been added to the Policy). Another concern was if the proponent of the project would undertake a water rights analysis, but it may be out of the scope of the Policy and the authority of the Board. County Counsel has been engaged, and requiring an analysis will not be included into the policy until a decision has been made with them. The Policy directs proponents to include any and all agreements associated with their proposal. This will provide details to the Board regarding the use of the water. The Policy also requires that the Monitoring and Contingency Plan be reviewed every five (5) years to ensure that compliance with the GSP is being met. Stakeholder concerns were raised that the Monitoring and Contingency Plan Chair Maulhardt adjourned the Executive Committee meeting at 3:30 p.m.
