MINUTES

Minutes of the Fox Canyon Groundwater Management Agency's (FCGMA) Executive Committee meeting held **Friday**, **October 11**, **2013** in the PWA Conference Room 346 at the Ventura County Government Center, Hall of Administration, 800 South Victoria Avenue, Ventura, California.

- A. <u>Call to Order</u> The meeting commenced at 3:00 p.m.
- B. Introductions In attendance were: (1) Lynn Maulhardt, FCGMA Executive Committee Chair; (2) Charlotte Craven, FCGMA Executive Committee Co-Chair; (3) Neal Andrews, FCGMA Executive Committee Alternate; (4) Gerhardt Hubner, WPD, Deputy Director; (5) Rick Viergutz, Groundwater Manager; (6) Jessica Rivera, FCGMA Interim Clerk of the Board; (7) Alberto Boada, Agency Counsel; (8) Tully Clifford, WPD, Director; (9) Reddy Pakala, Director, Ventura County Waterworks District; (10) Robert Eranio, Crestview Mutual Water Company (CMWC) and Las Posas Users Group (LPUG); (11) Bryan Bondy, Calleguas Municipal Water District (CMWD); (12) Bob Krimmer, Pleasant Valley County Water District (PVCWD); (13) Dave Souza, PVCWD; (14) William A. Miller, grower; and (15) Daryl Smith, grower.
- C. <u>Public Comments</u> Mr. Robert Eranio, CMWC and LPUG, commented on and provided (3) copies to Agency staff of a report reviewing the transfer request from Solano Verde Mutual Water Company to CMWC. He further requested the item be placed on the next meeting's agenda after Agency staff had the opportunity to review the report.
- D. Meeting Minutes

The Executive Committee approved the minutes from the September 13, 2013 meeting.

E. <u>Consider Las Posas Users Group's (LPUG) Proposed Ordinance Code Change to Chapter</u>

<u>5</u>

Mr. Gerhardt Hubner, WPD, Deputy Director, introduced this item and provided a brief background to the Committee. Mr. Bryan Bondy, CMWD, added the proposal was not specific to County Waterworks District, but would apply to any Municipal & Industrial (M&I) user. Mr. Rick Viergutz, Groundwater Manager, gave a presentation on this item, reviewing: (1) the Las Posas Users Group's proposed Ordinance Code change; (2) a flowchart of the current well permitting process; (3) a flowchart and staff's comments on LPUG's proposed process; and (4) a flowchart of staff's alternate proposed well permitting process. Mr. Viergutz concluded his presentation by stating Agency staff did not recommend moving forward with the current LPUG proposal, or changing the Ordinance Code to require Board consideration of Historical Allocation (HA) transfers. In addition, he stated if the Committee felt an Ordinance Code change needed to be considered, Agency staff then recommended they receive feedback from LPUG on staff's alternate proposed method before proceeding.

800 South Victoria Avenue, Ventura, CA 93009-1610 (805) 654-2014 FAX: (805) 654-3350 Website: www.fcgma.org Discussion ensued concerning possible scenarios involving historical allocation transfers relating to new wells, replacement wells and expansion of use on current wells. In addition, the group discussed whether an Ordinance Code change was needed, or if such changes could be resolved through a Resolution. The group agreed that an Ordinance Code change was not needed, however, a mechanism was needed in order to compel M&I providers and operators to submit joint historical allocation transfer requests.

The discussion then turned to what type of mechanism would be used. Chair Maulhardt commented it was important to note if an operator removed themselves from a provider and the Agency needed a process to track that. In addition, Chair Maulhardt made inquiries concerning: conditional use permits; required staff time; and if a fee structure was needed. Co-Chair Craven agreed with the Chair's comments and stated Agency staff would need to bring forth the information on the questions specified. Alternate Director Andrews agreed a fixed fee structure would be needed.

After much discussion, the group concluded a form should be included in the well permitting process, which would require the well owner and M&I provider agree on a historical allocation transfer. The transfer would need to be approved by Agency staff, and if no agreement was reached, the request would then go before the Board for approval. Agency staff noted this process would take care of new and replacement wells; however, a notification process would be needed if an existing well owner decided to remove themselves from their provider. Chair Maulhardt directed Agency staff to discuss this with LPUG and other entities to determine a solution. It was also suggested that Mr. Alberto Boada, Agency Counsel, look into the meaning of "discontinuance of service" as noted in the Ordinance Code.

Mr. Hubner inquired of the timeframe to return this item to the Committee, and the Committee responded to return by mid-November. Mr. Robert Eranio asked if this meant his request to have the Solano Verde item heard at the next meeting was bumped, and the Committee responded both items would be dealt with at the November Executive Committee meeting.

F. Adjourn the Executive Committee Meeting

Chair Maulhardt adjourned the Executive Committee meeting at 4:30 p.m.

• This transfer request was presented to the Executive Committee on September 13, 2013.


Applicable Ordinance Code Section


Sections 5.3.2., 5.3.4. and 5.3.5. provide for allocation to be transferred between M&I extraction facilities provided there is no net detriment to the aquifer system and it is equitable. In making this determination at a minimum the following is to be considered:

- the location of extraction facilities;
- the aquifer system being used;
- groundwater quality impacts of the transfer; and
- overall assessment of cumulative impacts.

Policy Implications

- Should an Operator be allowed to transfer all of their Historical Allocation, leaving the Operator with no future / or clearly inadequate groundwater allocation to meet potential future demand?
- Should the Allocation go to the water purveyor upon annexation?
- Should the receiving water purveyor receiving historical allocation be required to return that Allocation if a new well owner separates from the water purveyor?



- •In 1997 and 1999 delivered water for irrigation of 99.50 acres of mature lemons.

Solano Verde Mutual Water Company

- Extracted groundwater from two wells until 2005.
- Annual extractions approximately 200 to 300 AF/year.
- Wells were destroyed under permit in 2009.
- Currently provides water supplied by Calleguas Municipal Water District.
- Service area is within the Ventura County Water Works District No. 19 service area.

Solano Verde Mutual Water Company

- Origin historical allocation: 231.794 AF/yr.
- Three HA transfers approved: two in 2006 totaling 35 AF/yr; and one in 2010 for 51.793333 AF/yr.
- Current HA of 145.00067 AF/yr.
- Baseline allocation of 80.10 AF/yr
- In 2006 and 2007, credits (totaling 111.4 AF) were transferred from Solano Verde to Calleguas Municipal Water District for in lieu water deliveries.



• At full build-out, the maximum number of connections is to be about 700.





Crestview Mutual Water Company

Numeric Solutions Report


- The submitted consultant report was fairly thorough.
- Provided a good discussion of the hydrogeology.
- Evaluated groundwater extractions within a one-mile radius of the CMWC wells.
- Discussed water quality and present data on the BMO constituent concentrations in the vicinity of CMWC service area.
- Discussed the BMOs but did not mention that TDS concentrations in much of the basin exceed the Basin Management Objective for the basin.







PV - Pleasant Valley Basin Well 34C01 (gray infill) WLP – West Las Posas Basin Well 15M04 (black border, no infill)

TDS BMO for WLP Basin in less than 600 mg/L




TDS concentrations in mg/L (2005 - 2010)

- Should HA be transferred to the water purveyor who serves the customer base that developed the HA?


Options


- Permanently grant the HA transfer as requested.
- Conditionally grant the HA transfer to CMWC, but require that at the time of transfer, the HA per acre be recorded for the Solano customers, and provided back to them from CMWC if they install a private well.


Options

- Do not grant the HA transfer, but require the remaining HA to be assigned to the water purveyor which provides water to the Solano customers, where it could be prorated back if they install a private well and /or decrease the fees charged for the water that the customers are provided.
- Do not grant the HA transfer.
- Grant the HA transfer with the condition that an efficiency allocation is not available to parcels once served by SVMWC



Item B - Consider Zone Mutual Water Company's Proposed Changes to the FCGMA Well Permitting Procedure

Background

- October 11, 2013 The Executive Committee concurred with Agency staff that LPUG proposed Ordinance Code change was not recommended.
- In follow-up, Zone Mutual Water Company proposed an alternate change, the adoption and use of a questionnaire.
- The proposed questionnaire would replace the current FCGMA Application for Historical Allocation Transfer, and be submitted when one applies for a new well in the Las Posas basins.

Discussion

- The questions are geared towards evaluating if the new well/parcel/Operator qualifies for an Historical Allocation transfer.
- Built into the questionnaire is an assumed formula for calculating the amount of Historical Allocation that the new well would be entitled to.

Discussion

- The questionnaire does not provide the water purveyor's criteria, as to which wells are entitled to transfers, nor the formula for calculating the amount to be transferred, per each operating water purveyor.
- The questionnaire presupposes a mutual transfer request.

Discussion

• The proposed questionnaire would be useful for: acquiring supplemental information, including the logic behind the agreed upon Historical Allocation transfer amount; and initiating the first steps towards the allocation transfer process.

TIMELINE OF ACTIONS

- ➤ Request for transfer application submitted May 28, 2013.
- Staff reviewed application and decides to refer to Executive Committee.
- Executive Committee receives Staff presentation August 12, 2013, detailing various NEW concerns about HA Transfers and stating they do not have resources to complete necessary analysis.
- ➤ Crestview retains Numeric Solutions early September 2013 to complete analysis as required by Ordinance Code.
- Crestview submits report to GMA Staff on October 11, 2013 for review and comment.

APPLICABLE ORDINANCE CODE SECTION

Sections 5.3.2., 5.3.4. and 5.3.5. provide for allocation to be transferred between M&I extraction facilities provided there is no net detriment to the aquifer system and it is equitable. In making this determination at a minimum the following is to be considered:

- the location of extraction facilities; Section 2.1.1 on page 4
- the aquifer system being used; <u>Section 2.2 on page 5 6</u>
- groundwater quality impacts of the transfer; and <u>Section 4.2</u>
 <u>on page 11</u>
- overall assessment of cumulative impacts. <u>Section 6.0 on</u>
 <u>page 13</u>

GMA STAFF SPECIFIC CONCERNS THAT APPLY TO CRESTVIEW


What basin does Crestview draw from?

- "Historically, the FCGMA has attributed extraction at CMWC wells to the West Las Posas Basin. LPUG has concluded there is likely a hydraulic connection between this portion of the Camarillo Hills and the West Las Posas Basin. Our preliminary analysis of the geology near the CMWC's wells supports this conclusion."
- ➤ "The geologic analysis of CMWC's wells in the western Camarillo Hills suggests wells CMWC-4 and CMWC-6 are likely installed in aquifer materials correlatable to the LAS and or materials stratigraphically between the UAS and the LAS. Geochemical analysis supports this conclusion and indicates water from CMWC-5 (CMWC-4) and CMWC-6 is very similar to that of nearby LAS wells."


GMA STAFF SPECIFIC CONCERNS THAT APPLY TO CRESTVIEW

- Depressed water levels in and around Crestview facilities.
- "Extraction at wells near to CMWC's has been relatively stable since 1995. The aggregate average annual extraction at wells north of the Springville fault has declined by approximately 190 AFY since 2006."
- "Water levels in CMWC wells have been relatively stable at least since CMWC-6 was installed late 2005."

Should an Operator be allowed to transfer all of their Historical Allocation, leaving the Operator with no future / or clearly inadequate groundwater allocation to meet potential future demand?

"WHEREAS, Solano Verde desires to enter into an agreement to sell all of its remaining HA to CMWC, based upon ...studies performed by GMA, the drop in water levels after pumping...and pumping water in Solano is not conductive to a reliable and affordable supply of water now or in the foreseeable future."

GMA STAFF SPECIFIC CONCERNS THAT APPLY TO SOLANO VERDE

Should an Operator be allowed to transfer all of their Historical Allocation, leaving the Operator with no future / or clearly inadequate groundwater allocation to meet potential future demand?

- ➤ Solano CCR's Section 2.13 Drilling. "No water well drilling, development operations...of any kind shall be permitted upon any lot, nor shall...derrick or other structure designed for the use in boring for water...be erected, maintained or permitted upon any lot, except drilling conducted by SVMWC...within established well sites for that purpose."
 - ➤ Baseline of 80.10 Af/ Yr will remain
 - ➤ Approximately 1,800 Af of "Credits" will remain.

 - ➤ No comments or objections to presentation or follow up reports.

- Crestview has met the conditions and requirements of the Ordinance to allow the transfer
- Crestview has answered and addressed Staff concerns as presented in Aug 2013
- No Stakeholder or outside interest has expressed concerns or objections
- The Board of SVMWC passed a Resolution expressing a desire to transfer with clear language showing they understand the action
- The allocation will be pumped regardless of GMA's actions here today
- Moving the pumping from an area of limited recharge to an area with better recharge and high water levels
- Crestview respectfully requests the Executive Committee approve the transfer and place on the Agenda for the next GMA Meeting on December 4, 2013, with a recommendation to approve.
